
WARNING:

- Turn the power off before inspection, installation, or removal. Suitable for wet locations.
 Use only on 120Vac, 60Hz circuits.

What's In The Box



One (1) Driver with Three (3) Push-in Connector

Carefully unpack the downlight from its packaging. Inspect product for defects due to shipping.


Materials Needed

This LED Recessed Downlight requires very few tools for installation. A screwdriver, a wrench, and a pair of wirecutters will help to install the driver and downlight . Additionally, the installer must provide one Romex connector.

Tools Needed



Installing the RWG



Make sure all power is turned off before beginning installation





Optional:

Install Rough in Plate to ceiling joist at desired location using appropriate fasteners (not provided). Install drywall to ceiling using appropriate fasteners (not provided) and cut out Rough in Plate opening.

Make wiring connections as follows:

Open the driver cover, remove the knock-out, and attach a Romex connector to the junction box.







