



What's In The Box

Tools Needed

A screwdriver will be needed for installing the NLCSPSS1WH.

<p>1 Make sure the luminaire can be 0-10 dim to off and the driver has AUX output. Carefully unpack the unit from its packaging. Inspect product for defects due to shipping.</p>	<p>2 Turn off power to appropriate circuit at the breaker panel.</p>
<p>3 Remove the sensor socket cover on the fixture with a screwdriver or pry tool, and remove the wire from the back of the cover.</p> 	<p>4 Plug the push connector of the fixture into the sensor.</p> 
<p>5 Align the sensor with the opening on the fixture and snap into place. Continue with appropriate installation of fixture.</p> 	<p>6 Turn power ON and follow the Nicor NLC commissioning guide.</p> 



RESTORING FACTORY SETTING INSTRUCTIONS

Reset a sensor to factory settings by turning the power on and off multiple times. Follow the steps below:

1. Make sure the lights are off.
2. Turn on lights for 8 seconds; then turn the power off for 10 seconds.
3. Immediately turn the lights on and off, then wait for another 10 seconds. Repeat 3 times.
4. Turn the lights on for 8 seconds, then turn the power off for another 10 seconds. Repeat 2 times.
5. Turn the lights back on. Blinking lights indicate a successful factory reset. All previous settings connected to the app has now been deleted.

Note: Waiting for at least 10 seconds will ensure that the fixture is completely powered off. The duration will vary depending on the driver and the power supply. If the driver can cut power to the fixture within 3 seconds, then you may change the waiting period from 10 to 3 seconds to facilitate a faster reset time.

LIMITED WARRANTY AND DISCLAIMERS OF WARRANTIES

(NICOR) warrants that the Network Lighting Controls (NLC) made by NICOR to be free from defects in materials and workmanship, under normal consumer usage for a period of five (5) years from date of purchase. This limited warranty is a consumer's exclusive remedy, and applies only to new products purchased and used by consumers in the United States or Canada, which are accompanied by this written warranty.

This limited warranty extends only to first consumer purchaser, and is not transferable. A consumer wishing to invoke the terms of this warranty must first obtain an RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its discretion, repair, replace or refund the purchase price of any product that does not conform to this limited warranty.

This limited warranty covers only defects in material and workmanship associated with normal installation and intended use of the product.

Normal wear and tear
