



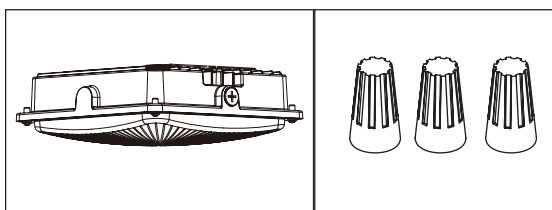
IMPORTANT SAFEGUARDS !

1. Risk of fire or electric shock. LED installation requires knowledge of luminaire electrical systems. Review the diagrams thoroughly before beginning. All electrical connections must be in accordance with local codes, ordinances, and the National Electric Code. If not qualified, do not attempt installation. Contact a qualified licensed electrician.
2. Before installation, disconnect the power by turning off the circuit breaker or by removing the appropriate fuse at the fuse box. Using the light switch to turn power off is not sufficient to prevent electrical shock.
3. To prevent wiring damage or abrasion, do not expose wiring to edges of sheet metal or other sharp objects
4. All parts must be used as indicated in the instructions.
5. The use of accessory equipment not recommended by the manufacturer may cause an unsafe condition.
6. To maintain Wet Location Rating, ONLY use UL approved wet location junction boxes and conduit.
7. Operating temperature: -40°C to 40°C

What's In The Box



One (1) OUC

Three (3) Wire Nuts

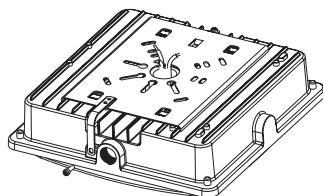
Tools Needed

A screwdriver, drill, a pair of wire strippers, and 4 fasteners appropriate for the mounting surface will be needed to install the OUC.



Make sure all power is turned off before beginning installation

- 1 Carefully unpack fixture from packaging and inspect for any damage caused in shipping.

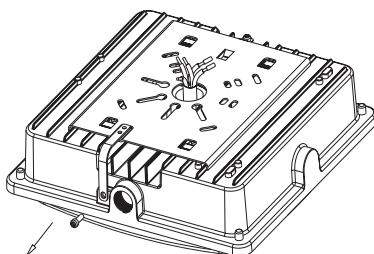


- 2 Turn off power using appropriate switch/breaker.

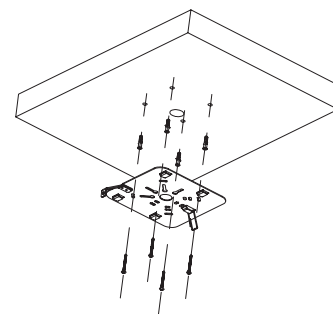
- 3 Locate desired positioning for the fixture on the mounting surface or junction box.

Mounting to j-box

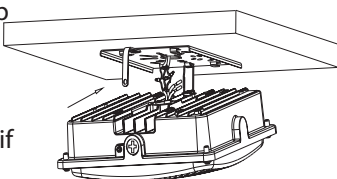
- 4a Loosen the mounting plate screw on side of housing and slide luminaire out.



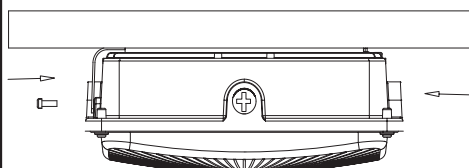
- 4b Fasten the mounting plate onto the ceiling/junction box and pull building wires through hole.



- 4c Fasten luminaire to the hinge clip and let hang. Connect the wires. Cap the dimming leads if not used.

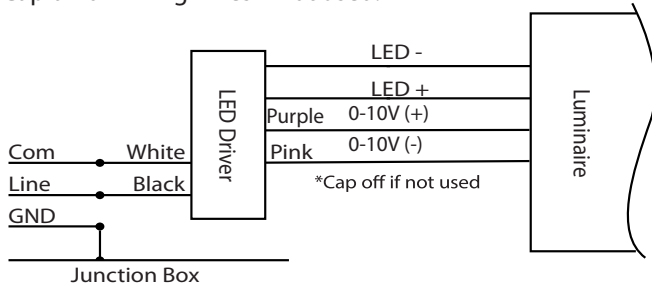


- 4d Slide luminaire into the mounting plate clips and fasten the mounting plate screw.

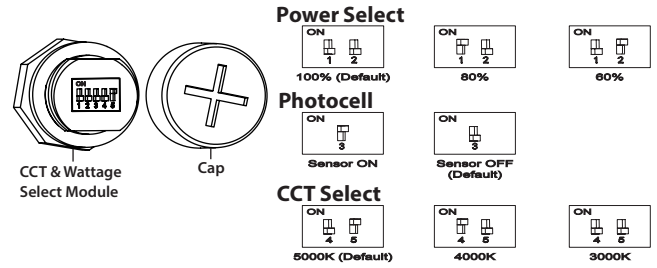


- 4e Check to ensure luminaire is securely fastened

- 4f** Connect wiring as shown in Wiring Diagram.
Cap off dimming wires if not used.

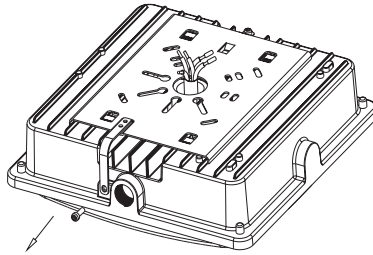


- 4g** The Product features selectable CCT and Power Select. Select desired CCT & Power. Reinstall cap.

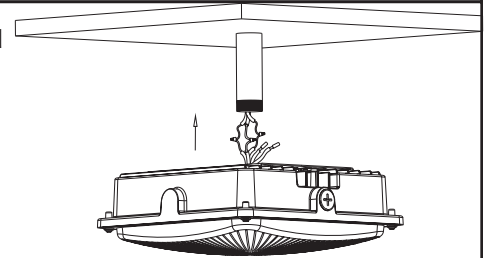


Mounting with a pendant

- 5a** Remove mounting plate by loosening the screw.
(NOT NEEDED FOR PENDANT MOUNT)



- 5b** Remove plug and twist in pendant conduit (3/4" SIZE OF THREAD AND HOLE) and follow wiring diagram



- 6** Check that fixture is firmly attached to mounting surface.

- 7** Turn power on (or energize fixture) and verify that the fixture is lit.

Subject to the exclusions below, each NICOR LED product, including the LED electronics and components of a property installed NICOR LED product, will be free from defect in materials and workmanship for a period of five (5) years from the original date of purchase. The product shall be considered defective only if 10% or more of the product's LED components fail. NICOR LED product warranty covers the following performance criteria: LED Light Output will be maintained above 70% of initial output; LED color temperature will not shift more than 200K in CCT; LED driver will operate within NICOR specifications; and the fixture finish, excluding natural aluminum or brass products, will not exhibit cracking, peeling, excessive fading, or corrosion during the warranty period. Exceptions apply as defined in NICOR's product specification sheets, which are incorporated by reference herein.

This limited warranty is provided to you, the purchaser of the product identified on Seller's invoice, as your exclusive remedy and applies only to NICOR products that have been purchased from an authorized NICOR Distributor; the product was new and in an unopened NICOR package at the time of installation; and the NICOR product was installed by a licensed electrician or under the supervision of a licensed electrician and used by consumers in the United States or Canada when accompanied with this warranty. This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement. This warranty requires that all repair/replacement estimates and costs, including but not limited to equipment rental (if any), and any other cost or expense to be incurred in the repair/replacement of the product, be approved in advance and in writing by NICOR. FAILURE TO OBTAIN NICOR'S ADVANCE WRITTEN APPROVAL OF ALL REPAIR/REPLACEMENT COSTS AND EXPENSES IN WRITING SHALL VOID THIS LIMITED WARRANTY.

THIS LIMITED WARRANTY DOES NOT COVER THE FOLLOWING:

- Defects or damages resulting from improper installation, operation, storage, misuse or abuse, accident, or neglect;
- Defects or damages resulting from improper service, testing, adjustment, installation, maintenance, alteration, connection to out-of-specification electrical service, corrosive or damp environments, or connection to incompatible equipment or devices (e.g., connecting non-dimmable lighting products to dimmers);
- Damage which occurs in transit;
- Power surges or overheating due to external conditions
- Acts of nature including but not limited to lightning strikes
