



WARNING

- Risk of burns. Disconnect power and allow fixture to cool before changing bulb or handing fixture.

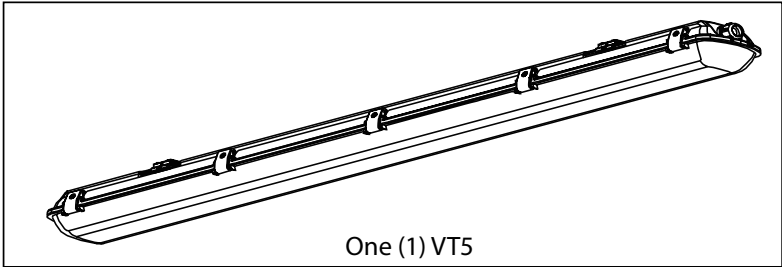

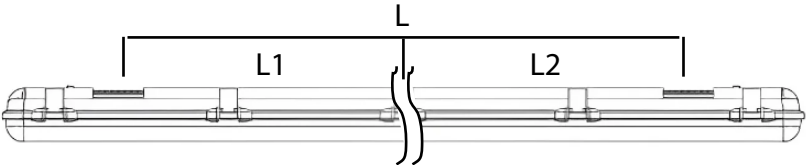


Tools & Materials Needed

This Vaportite Luminaire requires very few tools for installation. A drill or a screwdriver and a pair of wirecutters, and appropriate fasteners for mounting surface



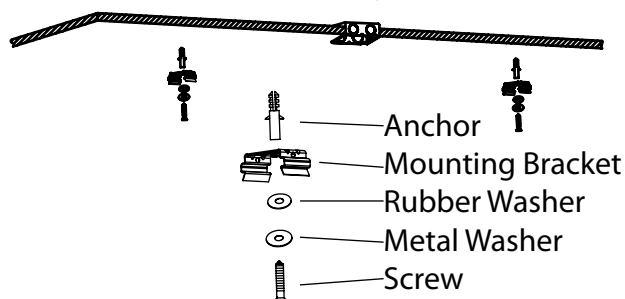

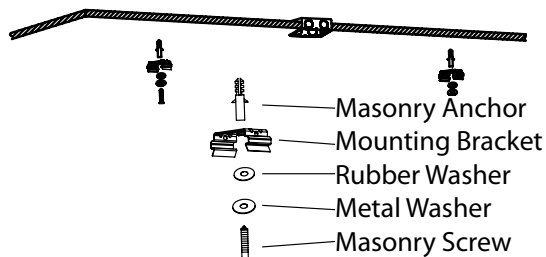

Surface Mount Installation

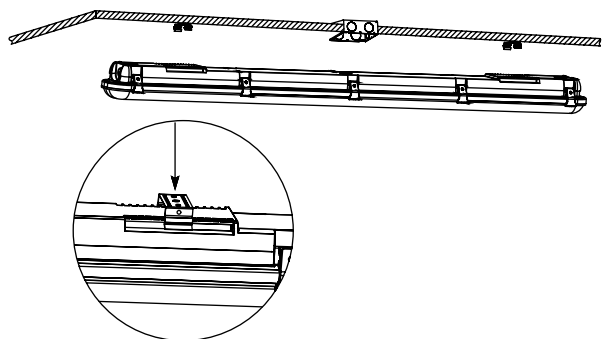
- 1** Locate and drill holes in mounting location per chart on page 1. Install mounting clips to surface using appropriate hardware.



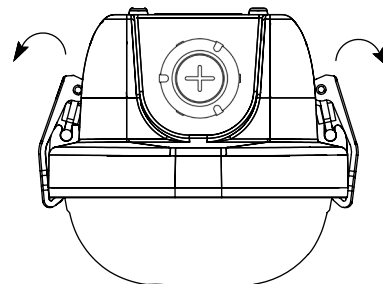
- 2** If installing into CMU block or other concrete surfaces use TAPCON or similar masonry anchors with the VT5 mounting bracket at locations per chart on page 1. Follow anchor manufacturer's instructions.



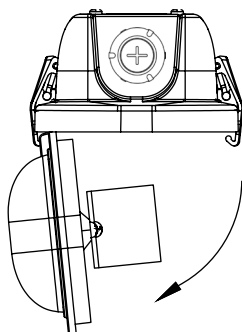
- 3** Press fixture housing into clips until both sides of the housing recesses are secured.



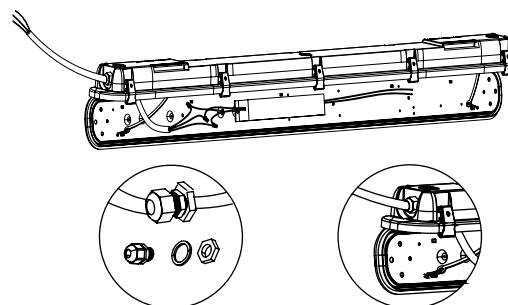
- 4** Release latches by pulling top of latch away and down from housing.



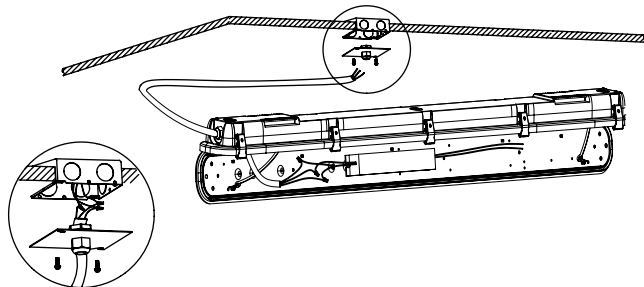
- 5** Detach LED tray and lens from fixture and let hang by hinges.



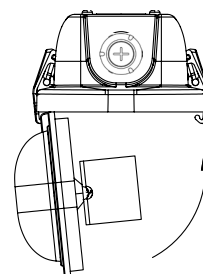
- 6** Connect power cord (supplied by others) to driver using provided cord grip in desired knockout.



- 7** Connect fixture to AC power following the wiring diagram for reference.

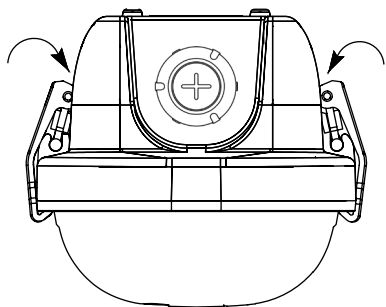


- 8** Reattach LED tray and lens to fixture by reversing step 4.



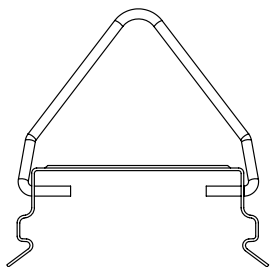
Surface Mount Installation (cont.)

- 9 Secure lens to housing with lens latches.

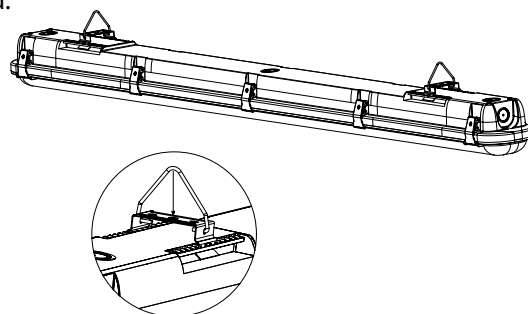


Chain Suspension Mounting

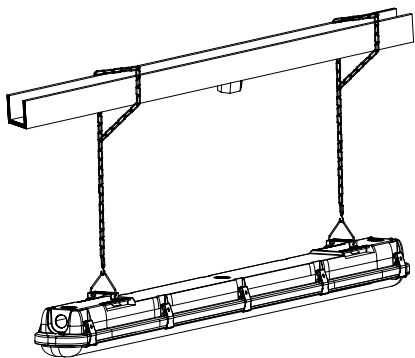
- 1 Attach v-hooks to each mounting clip by spreading the ends of the v-hooks apart and inserting the legs into the holes on the sides of the mounting clips.



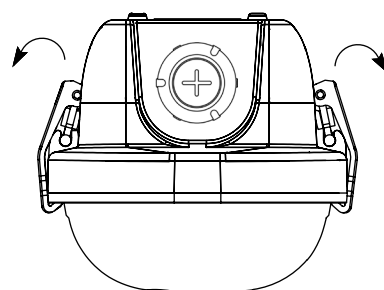
- 2 Secure mounting clips to fixture housing recesses by firmly pressing them into place until both sides of the clips are secured.



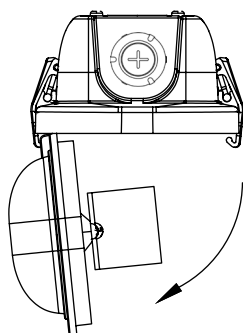
- 3 Hang fixture to the suspended chain (provide by others).



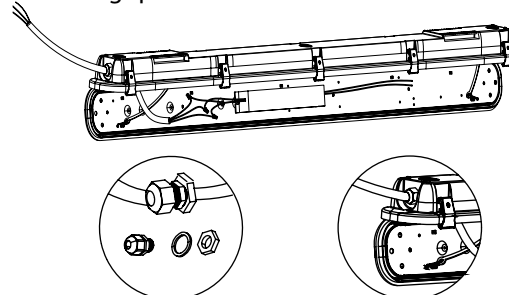
- 4 Release latches by pulling top of latch away from housing.



- 5 Detach LED tray and lens from fixture.

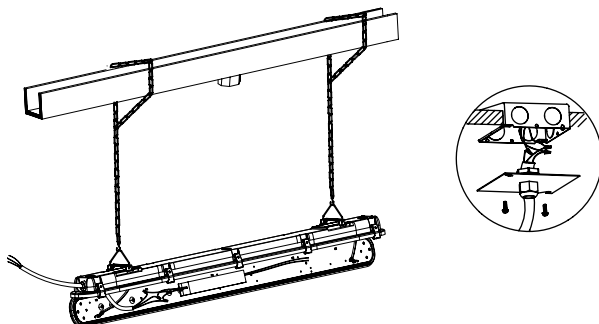


- 6 Connect power cord (supplied by others) to driver using provided cord grip in desired knockout.

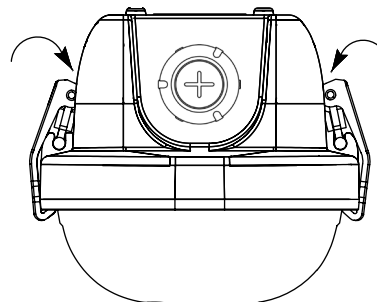


Chain Suspension Mounting (cont.)

- 7** Connect fixture to AC power following the wiring diagram for reference.

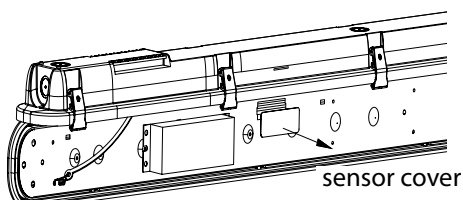


- 8** Reattach LED tray and lens to fixture by reversing step 5. Secure lens to housing with lens latches.

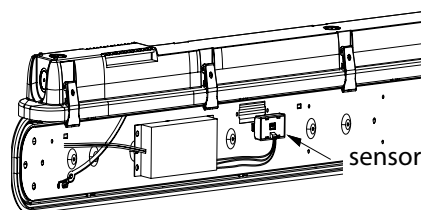


Sensor Installation - Internal

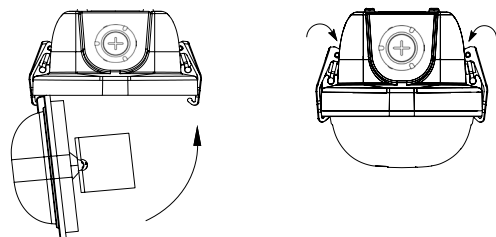
- 1** For Internal Sensor Installation :
Remove sensor cover from the LED tray by prying out.



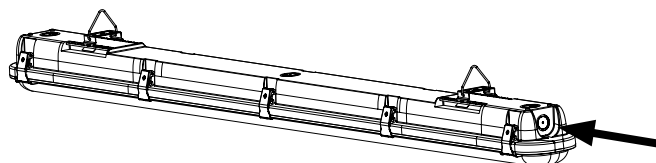
- 2** Connect the cable plug to sensor terminal, then snap sensor into the open knockout.



- 3** Reattach LED tray to fixture. Secure lens to housing with latches. Internal installation is complete. Apply power to the fixture and test sensor function.

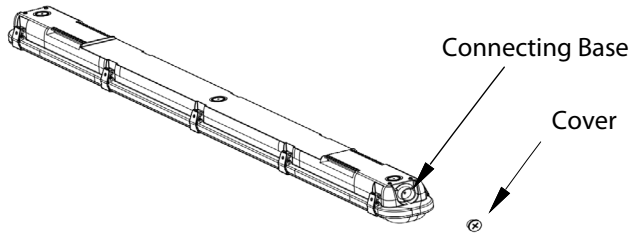


- 4** For external sensor installation: Remove socket cover from end of fixture and screw adapter arm into socket.

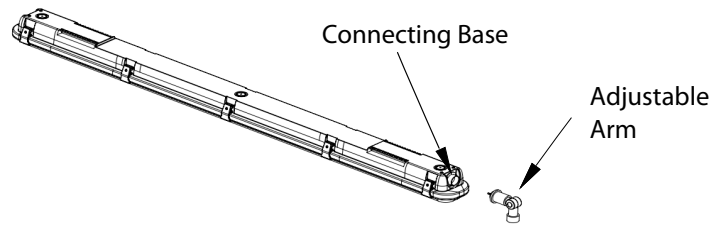


Sensor Installation - External

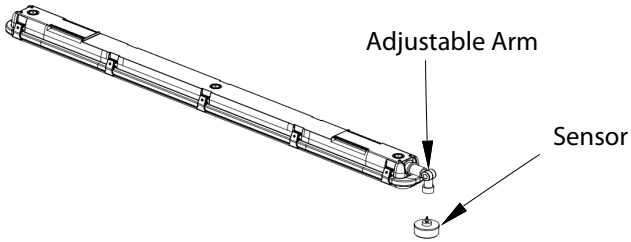
- 1 Remove socket cover from end of fixture with a screwdriver.



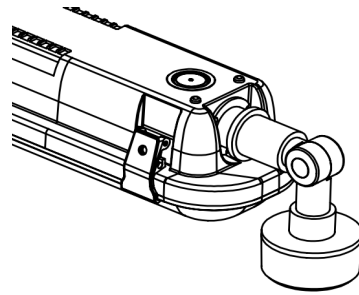
- 2 Screw the adjustable arm to the connection base/socket.



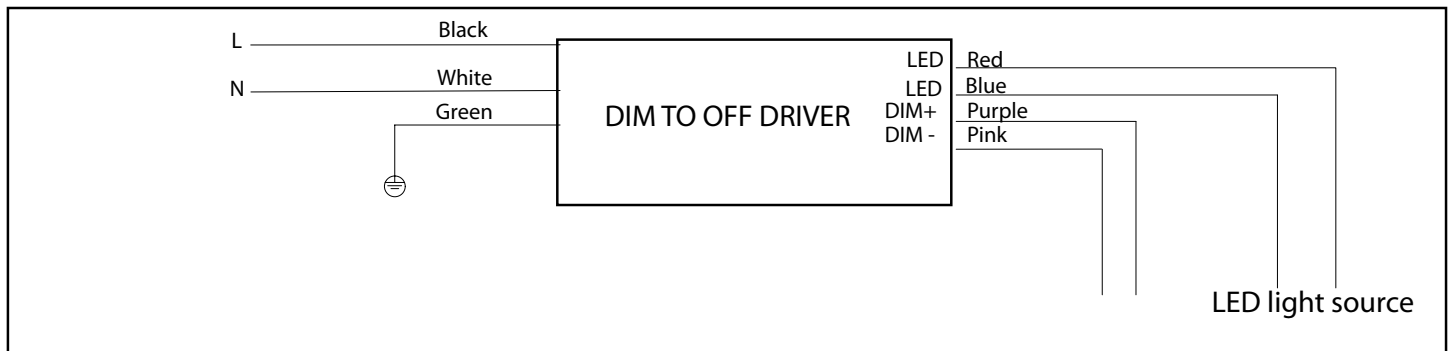
- 3 Screw the sensor into the end of the adjustable arm.



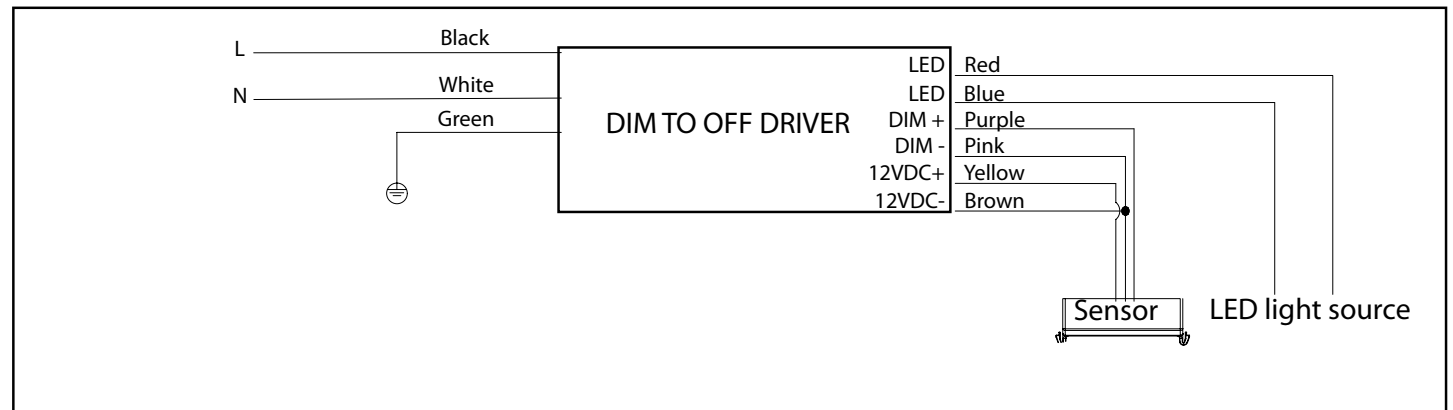
- 4 Adjust arm to have sensor face in desired direction.



Wiring Diagram

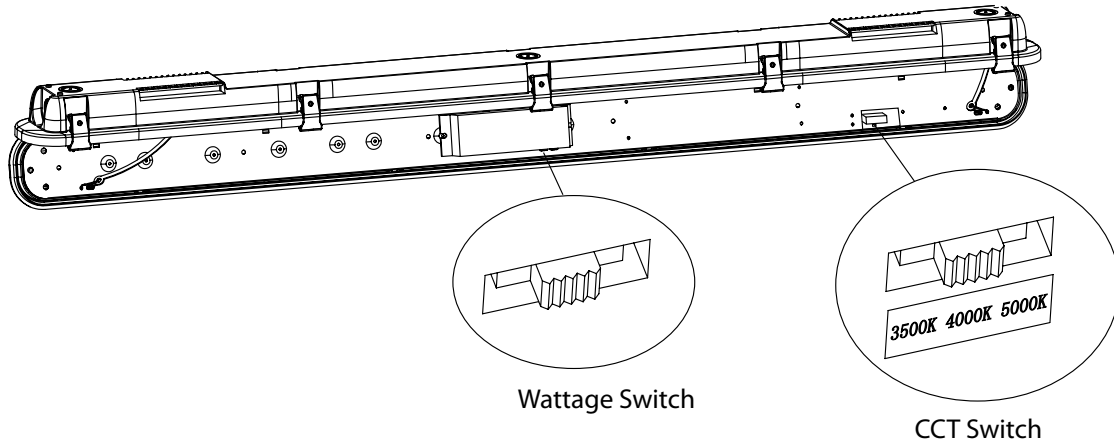


Standalone DC Sensor Wiring Diagram



Wattage and CCT Selection Switches

Wattage Selection and CCT Selection switches are located on the driver. To select the wattage, move the switch to Low-Med-High. To select CCT, move the switch to desired setting.

This limited warranty is provided to you, the purchaser of the product identified on Seller's invoice, as your exclusive remedy and applies only to NICOR products that have been purchased from an authorized NICOR Distributor; the product was new and in an unopened NICOR package at the time of installation; and the NICOR product was installed by a licensed electrician or under the supervision of a licensed electrician and used by consumers in the United States or Canada when accompanied with this warranty. This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement. This warranty requires that all repair/replacement estimates and costs, including but not limited to equipment rental (if any), and any other cost or expense to be incurred in the repair/replacement of the product, be approved in advance and in writing by NICOR.
